This is to advise that the Livermore City Council will conduct a public hearing at its meeting of November 25, 2024 beginning at 7:00 p.m. to consider the matters listed below:

A resolution authorizing the City Manager to execute a Power Purchase Agreement (PPA) with Ava Community Energy (Ava) to install solar and battery storage at critical municipal facilities. The PPA for the City of Livermore (City) comprises a six-site portfolio that will provide approximately 3,143 kW of solar and 6,346 kWh of storage to the City over a 25-year term. In addition to City of Livermore sites, the overall portfolio includes facilities from the Cities of Berkeley, Fremont, Hayward, Oakland, Pleasanton, and San Leandro. Ava's Critical Municipal Facilities program reduces barriers for local governments to deploy solar and storage by providing technical expertise, streamlining the contracting process, and reducing costs. This project will help the City of Livermore improve energy resilience, reduce greenhouse gas emissions, and reduce energy costs.

The City will make a determination that the project is exempt from the provisions of the California Environmental Quality Act (CEQA), pursuant to a Statutory Exemption (§§ 15260 — 15285) or Categorical Exemption (§§ 15300 — 15333), or both.

Hearing to consider a proposed residential subdivision for 44 units, consisting of 38 single-family detached units and 6 duet/couplet units and Recirculated Partial Final Environmental Impact Report (EIR) document, together with the Recirculated Partial Draft EIR published in July 2024, the Draft EIR published in November 2012, the Final EIR published in June 2014, and the Re-Issued Final EIR published in August 2019.

A proposed residential subdivision for 44 units, consisting of 38 single-family detached units and 6 duet/couplet units, on an approximately 31.7 acre vacant site located east of North Vasco Road, north of Garaventa Ranch Road/Altamont Creek Drive, and west of Laughlin Road. A proposed westerly extension of Bear Creek Drive would provide access to the internal residential street, and an emergency vehicle access (EVA), pedestrian, and bicycle bridge is proposed at Hawk Street.
